### Interview Arrangements for January 26, 2007

**Employer Pre-screening:** Employers will receive résumés on November 17, 2006 and will have until December 11, 2006 to review them and provide NYU with the names of selected students.

**Interview Schedules:** Preliminary interview schedules will be faxed to employers on January 10, 2007; final schedules will be available at check-in on Friday, January 26, 2007. Each schedule allows for seventeen twenty-minute interviews, with five minute breaks between interviews for note-taking and scheduled morning and afternoon breaks. The interview day begins at 9:00 a.m. and ends at 5:30 p.m.

Please complete the enclosed registration form and return with two copies of your organizational description or firm résumé (if you have not provided a Web site address) and check for registration fees made payable to New York University School of Law by September 1, 2006.

### Registration Fees: (includes continental breakfast and lunch)

The initial employer schedule fee is \$400. For every additional schedule (which includes one interviewer) there is a fee of \$150. The fee for each additional interviewer is \$100.

**Payment Methods:** Checks must be **drawn from U.S. banks or foreign banks with a New York office.** Alternatively, a correspondent law firm with a New York office may issue the check. Payments can also be made by Money Orders (including International Money Order) or by credit card (email Nakia Wade for the credit card payment form).
